# RESPONSIBILITIES, TERMS, AND CONDITIONS

#### **CANCELLATION POLICY:**

Tours de Sport, Inc. is herein referred to as TDS. If any reservation is canceled, the right to receive a refund is limited. All cancellations are subject to a processing fee of \$50 per person. Refunds will not be issued for cancellations received within 10 days prior to trip departure. ALL CANCELLATION FEES, INCLUDING THE PROCESSING FEE OF \$50 PER PERSON, WILL BE WAIVED IF THE GROUP PROVIDES A REPLACEMENT FOR THE CANCELED ROOM SPACE AND BUS SEAT. Notification of cancellation must be sent in writing to the group leader and shall be effective the date received from the group leader at TDS (There is no charge for name changes on the rooming list.)

Any change in the package, destination, or location is not sufficient grounds for cancellation providing: in the event the tour program substitution is of greater dollar value, as advertised by TDS, TDS will pay for the additional cost; in the event the tour program substitution is of lesser dollar value, as advertised by TDS, TDS will refund the difference in price between the tour program selected and the actual destination tour program. Refunds will be sent to the Group Leader or travel agency and are made on the specific condition that the acceptance of the refund releases TDS from all present or future claims by the participant.

#### **TOUR CONDITIONS:**

Prices quoted are for pre-formed groups consisting of a minimum of 46 passengers per motor coach. Collection and disbursement of all funds and communications relative to the tour is effected through the Group Leader or travel agency. If passenger counts fall below 46 passengers, Tours de Sport reserves the right to adjust pick-up and routing so as to add passengers, change trip destination, or cancel the tour for lack of sufficient participation. Change or delay in pickup time and/or pickup location are not sufficient grounds for cancellation. The published pick-up location shall be accommodated for groups paid in full and consisting of a minimum of 20 passengers.

Deposits and final balances with rooming list must be received by TDS on or before the appropriate due dates. Reservations for time and space can not be guaranteed unless secured by the timely arrival of required deposits, final payments, and rooming lists. Final payments and rooming lists are due to TDS no later than 21 days prior to your group's departure date. Arrangements shall be made for reservations paid in full, on time and upon the timely receipt of the final rooming list at TDS. Group participants under 18 years of age must have their parent or legal guardian sign this "Minor Release Form".

#### **RESPONSIBILITY:**

TDS acts solely in the capacity of an agent on behalf of its tour patrons in arranging for transportation, lodging, and any other services, and as such is not responsible for any act, error, or omission or for any damage, loss, delay, injury, or accident due to any act or default on the part of any company or person engaged in providing transportation, lodging, or other services which are part of the tour. TDS expressly reserves the right to withdraw any tour or to make any change in the tour that may become necessary, with or without notice, including substitution of accommodations or transportation.

In the event of inclement weather or other causes or events beyond the control of TDS which result in delays, it shall not be the responsibility of TDS to pay for resulting costs and expenses, including, but not limited to, additional lodging expense, additional meal(s) expense, or other similar expenses. In the absence of negligence on TDS's part, TDS is not responsible for losses or damages arising from physical or emotional injury, property or other economic damage caused by such factors beyond its control.

This form as well as personalized flyers printed by TDS for your group contains the Responsibilities, Terms and Conditions and other policies governing the tour. It is the Group Leader's responsibility to assure that all group participants receive the proper statement of "Responsibilities, Terms, and Conditions" and other policies as represented by TDS.

Unless otherwise indicated in writing, TDS DOES NOT provide chaperones for these tours. It is the responsibility of each group to provide their own adult chaperones (minimum of 2 per bus). These chaperones, and not TDS, will be responsible for monitoring the group's behavior and are responsible for the well being of the minors on the tour.

#### NO REFUNDS FOR UNUSED SERVICES:

Refunds or allowances will not be made for transportation, accommodations, services, or other portions of the tour which are unused on or after the tour departure date.

### **OPTIONAL ACTIVITIES:**

It is intended that all Optional Activities will be offered as listed in the brochure advertising the tour unless weather or other conditions prevail at that time that make it hazardous or impossible for individuals to participate in the activity. TDS does not act as an agent or operate any Optional Activity. The decision to participate in any Optional Activity is solely between the tour participant and the operator of the activity. TDS assumes no risk, liability or responsibility for incidents or accidents which may occur to an individual while participating in the activity. Some Optional Activities are subject to a minimum participation requirement. Payment for all Optional Activities must be made in cash.

#### **INSURANCE:**

Passengers are strongly advised to protect themselves with insurance. Optional cancellation, accident, health, and baggage insurance are available to protect tour participant(s) against unforeseen circumstances. Upon request, TDS or your travel agent will provide further information and rates. Insurance must be purchased no later than 21 days prior to trip departure.

#### **ACCOMMODATIONS:**

Room assignments are made by hotel personnel and not by TDS. "Double occupancy" does not necessarily mean that the room has two double beds. Triple and quad occupancy rooms WILL NOT have more than two beds per room. Rollaway beds (cots) are limited and will be provided on a first-come basis, if available at all. Many hotels cannot accommodate 5 people per room. Requests for these quint occupancy rooms cannot be assumed unless confirmed in writing by TDS. SMOKING IS NOT PERMITTED IN ANY ROOM OCCUPIED BY ANYONE UNDER 18 YEARS OF AGE. No rooming accommodations will be accepted with males and females in the same room if anyone in the room is less than 18 years of age.

# Tours de Sport Code of Conduct



Tours de Sport's "Ski Weekend Getaway" sponsored by your organization is a function which all participants look forward to. It is a time for fun and enjoyment, but it is also a time of **RESPONSIBILITY**. Each person on the tour should be aware of what is expected from him or her. Please familiarize yourself with the following:

- 1. No one is permitted to leave the hotel or the ski area or other tour sponsored activity without an adult chaperone.
- 2. Absolutely no possession or use of alcoholic beverages, drugs or tobacco products is allowed at any time or anywhere during the ski trip.
- 3. No one may stay in a room after curfew with a member of the opposite sex.
- 4. Everyone must be in his or her own room no later than the 1:15 AM curfew on Friday and Saturday night. This time may be changed at the discretion of Tours de Sport or the group's chaperones.
- 5. Common courtesy must be provided to all other members of the ski tour and to all other hotel guests. Loud or disruptive behavior will not be tolerated.
- 6. If the behavior and/or activities of individuals and/or groups within the organization are deemed intolerable by; the chaperones, representatives of Tours de Sport, hotel personnel or members of law enforcement, the entire group will face immediate expulsion from the ski tour and everyone on the ski tour will be taken home. This may mean that even those not directly involved may suffer the consequences of returning home prior to the end of the tour and all monies paid will be forfeited.
- 7. Any infraction of the above rules may result in immediate expulsion from the ski tour. Parents will be contacted and may be required to come immediately to take their child home.
- 8. All decisions made by the organization's chaperones or Tours de Sport personnel are final and not open to interpretation or discussion.
